2. A credit inquiry by VIKING BOND SERVICE, INC may appear on the credit report or reports of any applicants or owners indicated to be holding ten (10) percent or more stock in the company or entity for which bonding is being applied for.
3. VIKING BOND SERVICE, INC will assume that the officer or applicant signing below represents the company or entity requesting bonding, its stockholders holding ten (10) percent or more of stock, and will make credit inquires accordingly.
4. Whenever used in this instrument, the plural term shall include the singular and the singular shall include the plural, as the circumstances require. If any portion of this Agreement is construed to conflict with any law applicable hereto, such portion of this instrument shall be considered to be deleted and the remainder shall continue in full force and effect.
